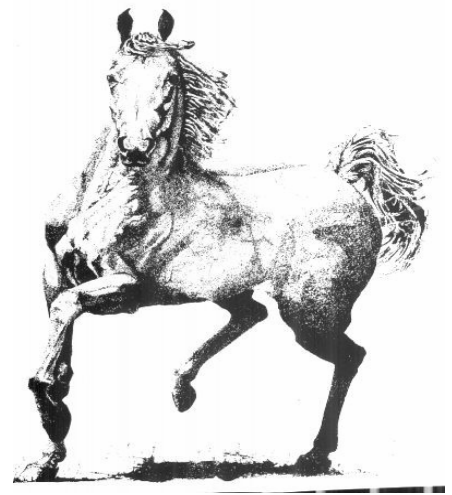

Code Ann. 27-1-725 through 727.

In the event a claim is made which directly or indirectly results in liability exposure to THE MISSOULA HORSEMEN'S COUNCIL AND MISSOULA COUNTY its heirs, personal representatives, successors, assigns, agents, partners, employees, insurers and attorneys for losses, injuries, and damages related to equine-related activities, the undersigned covenant(s) and agree(s) to indemnify and save THE MISSOULA HORSEMEN'S COUNCIL AND MISSOULA COUNTY its heirs, personal representatives, successors, assigns, agents, partners, employees, insurers and attorneys harmless from all such claims and demands, including reasonable attorney fees and all other expenses necessarily incurred
